1977 Western Division AFS Meeting to be held in Tucson, July 10-13

The meeting will be held at the Tucson Marriott Hotel, 180 W. Broadway, Tucson, AR, 85701. A toll free reservation phone is available; dial 800-228-9290. Rooms go for \$20 single and \$26 double. Students with identification may obtain rooms for \$16 for four persons.

PROPOSED AMENDMENT TO THE AFS CONSTITUTION

The proposed amendment allows the selection of the Parent Society meeting locations by an annual mail ballot.

Article IV, Meetings and Voting:

The Society shall meet once a year at a time and place to be ~~decided upon by the membership at the preceding regular or annual meeting or in default of such decision by the membership, by the Executive Committee~~ determined by a mail ballot which shall include at least two comparable choices that are derived from a competitive bidding procedure as specified by the Executive Committee.

BEING PLANNED

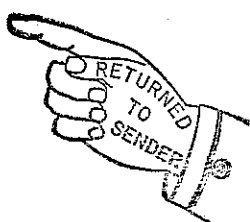
